

Revision of Cable Charges for Telegraphic Transfers (Individuals and Corporates)

With effect from 1st July 2016, the cable charges for telegraphic transfers will be revised as follows:

Telegraphic Transfer (“TT”) ¹	Charge
TT to Malaysia	S\$20 per TT
TT to all other countries except Singapore and Malaysia	S\$30 per TT

¹TT in Singapore Dollars or any foreign currency acceptable to UOB.

Save as expressly mentioned herein, all the other terms and conditions in the (i) *“Terms and Conditions Governing Accounts and Services (Individual Customers)”*; or (ii) *“Terms and Conditions Governing Accounts and Services (Non-Individual Customers)”* and *“Additional Terms and Conditions Governing Accounts and Services (Non-Individual Customers)”*; and all documents relating to your UOB Deposit Account(s) and Service(s) shall remain unchanged and continue to be binding on you.
